



Polling - attitudes towards renewable energy in the Hunter

Renew Australia for All commissioned research firm 89 Degrees East to conduct polling on the shift to a renewable-powered economy nationally and in Renewable Energy Zones, including 373 residents in the Hunter region. The key results for the Hunter region show that:

- **71% of Hunter residents think Australia will benefit from shifting to renewable energy**, 67% think investing in renewable energy will be good for regional Australia, and 67% support the Australian government investing more in renewable energy.
- 73% of Hunter residents see renewables and batteries as the fastest way to bring down our energy bills, compared to 14% for nuclear reactors and 9% for building new coal power stations.
- Only 9% of Hunter residents oppose Australia shifting to renewable energy, compared to 68% who support the shift.

Methodology

The survey was administered online with recruitment sourced through a quality consumer opt-in panel, Pure Profile, providing access to over 1 million Australians.

This research was conducted by research firm 89 Degrees East, as part of a poll with a total sample size of 3,766 Australians, including a nationally representative poll of 2,004 Australians, with additional boost sampling of 1,762 Australians in renewable energy zones.

The Hunter result is an n = 373 sample of people living in the Hunter region aged 18+, using a high-quality consumer opt-in panel provided by Pure Profile. Recruitment was designed to ensure representative coverage of residents within the Hunter zones, with targeted sampling boosts to enhance data reliability.

The confidence level of the general population sample is +/- 2.08% at the 95% confidence level. Fieldwork was conducted by 89 Degrees East between Thursday, 8 August, and Wednesday, 21 August 2024. 89 Degrees East is a member of the Australian Polling Council.
